

## **MODEL RELEASE** **(International Version for All Countries and Regions)**

This Agreement governs the compensation, ownership rights, and use of photographs and derivative works thereof (hereinafter referred to as "Images") made by the Photographer of the Model for all lawful purposes, subject to the terms and conditions set forth below.

The basis for this contract is a non-commercial agreement, under which the Model enters into this Agreement with the purpose of acquiring new experience and driven by the desire to share their talent and help as many photo enthusiasts as possible create high-quality creative photo content and receive in return social (non-financial and non-monetary) rewards from the mentioned photo enthusiasts such as likes, approvals in comments and other social manifestations of approval. And a photographer, a person passionate about photography, has the opportunity, thanks to the LiveStage platform, to enter into a creative collaboration with a model and make high-quality photo content, enters into this agreement to satisfy their creative needs, and thanks to their talents, take a photo of the model, show the model in the best possible way, as imaginatively and creatively as possible. Thus, the Photographer will provide photography services to the Model without any payment to the Model, and the Model will provide modeling services to the Photographer without any payment to the Photographer in accordance with the following definitions and provisions:

- The term "Image" or "Images" shall refer to and mean photographs of the Model created by the Photographer on the LiveStage application.
- Images created by the Photographer on the LiveStage application with the participation of the Model are created for non-commercial use. All copyrights to Images created on the LiveStage application are non-commercial in nature.

The photographer, guided by aesthetic considerations and taking the shooting concept into account as much as possible, selects the most successful shots and can use post-processing on them to maximally emphasize the natural beauty of the model, her good physical shape, and other advantageous aspects, and also frames her taking into account the decorative elements of the location.

The model can contact the photographer with wishes to change or remove the photograph from the public space and, based on the principles of goodwill and to achieve satisfaction from joint creative activity, the photographer undertakes to make every possible effort to resolve the situation without conflict. In case it is impossible to reach a compromise between the photographer and the model, the photographer is obliged to remove such a photo at the model's request.

**Reproduction Rights.** The Photographer grants the Model non-exclusive, irrevocable rights to reproduce the Images.

The Model agrees that the copyrights, moral rights, and all other intellectual property rights to the non-commercial use of the Image (personal use, use on social networks, photo exhibitions, provided that such photo exhibitions are non-commercial, admission to the exhibitions is free and nothing is sold at these exhibitions, and the photographer should not derive any money from these photographs in any other way at exhibitions) belong to the Photographer and/or his/her heirs, licensees or assigns with a restriction on use, namely: for personal (non-commercial) use.

The Model agrees that, although he/she may use the Images for purposes related to the promotion of the Model's business, including, but not limited to, advertising, portfolio, exhibitions, competitions, and promotional websites, the Model will not transfer, license, sell,

lease, commercialize or otherwise provide any rights to reproduce any Images to any third party, either permanently or temporarily without the photographer consent.

Model confirms that they are over 18 years old and if the law in their jurisdiction requires that they must be older than 18 years old to participate in this photoshoot and sign this agreement lawfully without parental consent - model confirms that they are older than such age. The Model also declares that they can enter into contracts on their own behalf without violating any prior agreement or applicable law, including, but not limited to, prior agreements with modeling and talent agencies.
